



# **Digital Statement on a Foreign Vocational Qualification (DAB)**

German: Digitale Auskunft zur Berufsqualifikation

The Digital Statement on a Foreign Vocational Qualification (DAB procedure for short) certifies that the nonacademic vocational qualification acquired abroad has been completed, that it is recognised in the country of origin and that it is equivalent to a two-year full-time vocational training programme. The application for the procedure is submitted digitally to the Central Office for Foreign Education (ZAB). The results are issued in a notice, which can be used as a proof of qualification.
